Sub: Annual General Body Meeting of SRPOA at Chennai.

In the last Executive Committee Meeting of SRPOA held at Chennai on 27<sup>th</sup> August 2021, it was decided to conduct **Annual General Body Meeting of SRPOA on 22<sup>nd</sup> October 2021 (Friday) at Chennai.** The last meeting of the present Executive Committee will be held on the previous day (i.e.21.10.2021).

The Elections to the Executive Committee of SRPOA is being held once in two years and it is due during the ensuing AGM for the following posts as per our Constitution:

President	<i>One Post</i>
Working President	<i>One Post</i>
Vice-President	<i>Two Posts</i>
General Secretary	<i>One Post</i>
Jt. Secretary	<i>Three Posts</i>
Treasurer	<i>One Post</i>
Asst. Treasurer	<i>One Post</i>
Executive Committee Member to represent Headquarters	<i>One Post for each department of the organized cadre &amp; 2 posts for Miscellaneous cadre</i>

The election of Office-bearers shall be conducted in the following manner:

1. Nominations for each post, duly proposed and seconded, shall be sent to " The General Secretary/SRPOA, Ground Floor (PREM Office), General Manager's Office, Park Town, Chennai 600 003" in a sealed cover superscribing "**NOMINATIONS**" on the cover so as to reach **on or before 18.00 hrs. of 18<sup>th</sup> October 2021 (Monday).**
2. **Eligibility to Contest:**
  - (i) A member who has not paid the Subscription for the last one year from 01.08.2020 to 31.07.2021 is not eligible to contest in the election unless he/she renews his/her membership with a renewal fee of Rs.100/- in addition to the normal Subscription for the year.



- (ii) A member of the Association can contest only for ONE POST in the election.
- (iii) The last date for withdrawal of Nomination is 17.00 hrs. of 20<sup>th</sup> October 2021.
- (iv) The Nominations will be scrutinized and valid nominations shall be placed before the General Body.
- (v) Candidates securing the maximum number of votes shall be declared as elected to the particular post. In case of a tie, the result shall be decided by a lot.
- (vi) **Eligibility to Vote:** Every Member shall have the right to cast one vote for each post. A member will be eligible to vote provided he/she is not in arrears of Subscription from 01.08.2020 to 31.07.2021.
- (vii) While proposing a member for a particular post, the consent of the Member to be elected should be available irrespective of the fact that he/she is present in the AGM or not. The proposer shall invariably ensure to obtain the written consent of the candidate for any Post of Office Bearer or Executive Committee Member. The physical presence of candidate shall not be insisted upon during the Election process. The proposer may keep in view that the candidate whom he sponsors for the post of Office Bearer / Exe. Comm. Member will be able to dedicate sufficient time for the activities of the Association willingly.
